

**DEUTSCHE BANK A.Ş. DATA SUBJECT APPLICATION FORM**  
(Regarding Applications to be Made by Personal Data Subjects to the Data Controller)

**GENERAL EXPLANATIONS**

Pursuant to the Personal Data Protection Law No. 6698 (the “Law”), individuals defined as data subjects (“Data Subject”) are granted certain rights regarding the processing of their personal data under Article 11 of the Law.

According to Article 13, paragraph 1 of the Law, applications regarding these rights must be submitted to Deutsche Bank (“Data Controller” or the “Bank”) in writing or by other methods determined by the Personal Data Protection Board (“Board”). Within this framework, applications to be made to our Bank “in writing” must be submitted using this form:

- By registered mail with return receipt, or
- By applying in person to the address specified below.

In addition, applications may also be sent via registered electronic mail (KEP) to the address [db.iletisim@db.hs03.kep.tr](mailto:db.iletisim@db.hs03.kep.tr) with the subject line “Information Request within the Scope of the Personal Data Protection Law.”

Below are the details regarding the written application channels through which written applications may be submitted to us:

- Registered Mail with Return Receipt;  
By sending to the address *Esentepe Mahallesi, Büyükdere Caddesi, Ferko Signature No: 175/149 Şişli 34394 İstanbul, Turkey*, with the envelope marked as “**Deutsche Bank Personal Data Administrator.**”
- In Person;  
By applying in person to the address *Esentepe Mahallesi, Büyükdere Caddesi, Ferko Signature No: 175/149 Şişli 34394 İstanbul, Turkey*, indicating that it is a “**Deutsche Bank Data Subject Application.**”

The above-mentioned channels are the “written” application channels as required under Article 13, paragraph 1 of the Law. Once other methods determined by the Board are announced, our Bank will also make public how applications will be received through those methods.

Applications submitted to us will be responded to “as soon as possible and within thirty days at the latest” free of charge, depending on the nature of the request, in accordance with Article 13, paragraph 2 of the Law, from the date the request reaches us. However, if the process requires an additional cost, a fee may be charged by the Bank in accordance with the tariff determined by the Personal Data Protection Board. Our responses will be delivered to you in writing or electronically in accordance with Article 13 of the Law.

Depending on the nature of this form and your request, it is necessary that the information and documents requested from you are provided to us completely and accurately. In the event that the requested information and documents are not duly provided, there may be difficulties in conducting the investigations to be carried out by our Bank in a complete and qualified manner in response to your request. In such case, the Bank reserves its legal rights. Therefore, the relevant form must be submitted in full and in a manner that includes the information and documents requested, in line with the nature of your request.

**IDENTIFICATION OF THE APPLICANT AND CONTACT INFORMATION REGARDING THE APPLICATION**

In order for us to identify the “applicant” in connection with your application and to conduct the necessary investigations within our Bank depending on the nature of your request, the following information must be provided.

In addition, the contact information listed below is requested from you for the purposes of obtaining further details about your application, informing you about the progress of our review processes, and communicating the results of your application to you.
